Freeman moved, Carroll seconded to approve a Water Payment Policy-There has to be a three employee minimum, to use payroll deduction, to pay their water bills. MOTION CARRIED. 3. ACTION STEP- There will be no change regarding credit card payments at this time. Shane has been looking into contracts, and pricing with other companies, and has no final answer for the council at this time.

SPECIAL REPORTS:1. Barb Moss, Assessor for Duplain Township, was here to discuss the reappraisal being done in the Village of Elsie, in the spring/summer of 2019. She is requesting that the Village help pay for this reassessment, to help Duplain Township. This will be looked at during the next budget year. 2. ACTION STEP: Dan Armentrout, P.E., with the Clinton Count Road Commission, was available to discuss the repaving of Island Rd and Main St., from Shepardsville Rd. to Knowlton St., in the Village of Elsie. The cost to the Village would be 20% of the cost or \$18,620.00. A contract will be necessary, between the Village of Elsie and Clinton Co. Road Commission, by November 2018. The road will be worked from mid-May until the end of June, 2019. 3. ACTION STEP: Mark Rogers, a representative with City Wide wi-fi was here to discuss placing wireless wi-fi on the water towers. The camera on Main St. has also been helping with identifying roll-through cars at the light. 2. There is a pot hole that needs to be filled in on First St. 3. The Huntington Bank branch in Elsie is closing as of January 8, 2019. They will not sell it to another financial institute. There is a possibility of making it the Village Office if donated by Huntington Bank. 4. Dawn Levey was present to confer that she is running for State Representative, 93rd district. 5.
