Roll Call Vote- Ondrusek-Aye, Carroll-Aye, Freeman-Aye, Carie-Aye, Hyland-Aye and Ornelas-Aye, Frink-Aye. MOTION CARRIED.

The police department is going to be acquiring a new police officer, with more hours and visibility. 4. Larry Melvin requested to take care of maintenance of lawns, with a contract. It was explained that the Village cannot make a contract for someone else's lawn maintenance. There is currently a rotation list to mow property that is in ordinance violation. Mr. Melvin will be put on the mowing rotation list.

TREASURER: 1. Freeman moved, Frink seconded to approve the February 2017 Treasurer's Report as written. MOTION CARRIED. 2. Ondrusek moved, Ornelas seconded to approve the 2016-2017 budget amendments as written. MOTION CARRIED. 3. The purchase and implementation of the BSA Receipt Program, for the water bills, will begin as of April 1, 2017.

POLICE REPORT: 1. Ondrusek moved, Freeman seconded to approve the February 2017 Police Report as written. MOTION CARRIED. 2. Frink moved, Carroll seconded to approve the 2016 Annual Police Report as written. MOTION CARRIED. 3. POLICE COMMITTEE: J. Ondrusek, T. Frink and J. Hyland were appointed to the Police Committee. This committee will research police activity, hours scheduled, and accountability of the department.

COUNCILMEMBERS: The former jr. high has been purchased through state tax sale. The owner is going to be contacted and requested to demolish.

PUBLIC COMMENT: 1. There was a question regarding salting and scraping the streets after a snow storm. 2. There was an invitation, by the Reppenhagens, to meet at the old Harvest Market at 8:00 pm to address the sale of the building. Paperwork is to be signed March 15, 2017. 3.
