WHEREAS, the Village of Elsie, pursuant to Act 288 of the Public Acts of 1976 as amended, MSA 26.430(101) et seq., MCLA 560.101 et seq., is granted the authority to vacate, discontinue, or abolish any street, alley, or right-of-way;

WHEREAS, a public hearing has been held by the Village Council and no objections, in writing, have been filed with the Clerk of the Village of Elsie to the vacating of the alley as described in Exhibit A;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Elsie as follows:

- 1. That the Council of the Village of Elsie finds that no objection has been filed to the vacating, discontinuance, or abolishment of the alley described in Exhibit A, and the Council of the Village of Elsie finds that the abandonment of the alley will facilitate the development of adjacent property, and there is no public purpose to continue the use and ownership of alley as hereinafter described.
- 2. That the Council of the Village of Elsie hereby vacates, discontinues, and abolishes the alley, which is legally described on the attached **Exhibit A.**
- 3. That the Village of Elsie expressly reserves a utility easement for any public or private utilities installed or to be installed in, on, or under such vacated, abandoned, and abolished area.
- 4. That the Village Clerk is hereby directed to record this Resolution evidencing the Council Action indicated above.
- 5. That in the event a request is made to vacate the reserved utility easement that the valuation to be paid by the property owner be revisited.


